AN ORDINANCE to amend Ordinance NO. 10,406 M.C.S., as amended, relative to a conditional use previously adopted by the Council of the City of New Orleans (as administratively amended by Ordinance No. 12,554, M.C.S., as amended), to authorize and approve, pursuant to Article 15, Section 2.12 of the Comprehensive Zoning Ordinance of the City of New Orleans, an Administrative Amendment to Zoning Docket No. 76/84 to extend Off Track Betting to the live racing season and to amend or delete provisos concerning the operation of the New Orleans Fair Grounds Race Track, generally bounded by Gentilly Boulevard, Mystery Street, Esplanade Avenue, Bayou St. John and Belfort Avenue; and otherwise provide with respect thereof.

WHEREAS, Zoning Docket No. 76/84 is proposed to be administratively amended to extend Off Track Betting to the live racing season and to amend or delete provisos concerning the operation of the New Orleans Fair Grounds Race Track, generally bounded by Gentilly Boulevard, Mystery Street, Esplanade Avenue, Bayou St. John and Belfort Avenue; and otherwise provide with respect thereof.

1           SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY  
2           ORDAINS, that Ordinance No. 10,406, M.C.S., Calendar No.  
3           12,334, as amended, is hereby amended and reordained to read

6           SECTION 4. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY  
7           ORDAINS, that the following Administrative Amendment to Zoning  
8           Petition Docket No. 76/84 Ordinance No. 10,406, M.C.S.,  
9           Calendar No. 12,334, as amended, for the property hereinafter  
10          described, be and it is hereby authorized and approved. Said  
11          property and amendment are more particularly described as

12 follows:

13 PROPERTY DESCRIPTION:

14 New Orleans Fair Grounds Race Track, generally bounded by  
15 Gentilly Boulevard, Mystery Street, Esplanade Avenue, Bayou  
16 St. John and Belfort Avenue.

17 AMENDMENT:

18 To extend Off Track Betting to the live racing season; and  
19 that Proviso No. 1 of Ordinance No. 12,554, M.C.S., as  
20 amended, be amended to read as follows:

- 21 1. The parking lot lights shall not be turned on beyond the
- 22 end of the Club House (Mystery Street or Verna Street
- 23 end) during a normal O.T.B. operation. The parking lot
- 24 lights in this area shall be turned off within 45 minutes
- 25 of the last O.T.B. event. The parking lot lights outside
- 26 of the Clubhouse area shall be turned off within 45
- 27 minutes of the last live race of the day."
